The MRAA Membership Secretary's (Anton Lange) email cannot reach all members. The meeting is now technically illegal under the MRAA Constitution because the time limit for notification of all members is 21 days. This is usually achieved with the MRAA Magazine but MRAA President Alex Money and MRAA Vice President Marcel Gomperts did not like some of the contents on footpath parking, wire rope barriers and so forth and the mag did not get approval for printing and postage in time (or at all).

A meeting can be held on June 21, 2003. BUT it can't be a formal Quarterly General Meeting (QGM). No decisions/motions are binding on the MRAA Board under these conditions. Many think the MRAA Board are quite happy with this situation.

It is time to call a Special General Meeting (SGM) to find out just what Money's crew have been doing with members funds and what deals have been done with people like Assistant Commissioner of Police, Ray Shuey. Think about wire rope barriers (WRBs), footpath parking, compulsory front ID for motorbikes & scooters and your membership fees. Can you afford to go until the September QGM with no member-generated policy decisions and no info on what your money has been spent on?
